# VICTORIAN VILLAGE TOWNHOUSE CORPORATION AMENDMENT TO BY-LAWS

This Amendment of the By-Laws of Victoria Village Townhouse Corporation dated MARCH 2. 1996 is effective as of the date of filing for record and is executed by the President of Victoria Village Townhouse Corporation on behalf of the owners of not less than the required majority of the owners of units at Victorian Village Townhomes.

- 1) By instrument dated May 25, 1967 styled Declaration of Covenants Conditions and Restrictions and additionally dated April 10, 1967 and Styled By-Laws of Victorian Village Townhouse Corporation and recorded at Film Code #193-31-1444 et seq/ pro in the Property records of Harris County, Texas the developers of said Townhomes known as Victorian Village Townhomes subjected said tracts and improvements to a Townhome regime. Reference is hereby made to said recorded Declaration and By-Laws and all amendments thereto, if any, and said By-Laws and amendments are hereby incorporated herein by this reference as if set out verbatim. All defined terms used in the Declaration, By-Laws and amendments shall have the same meaning when used herein.
- 2) Article XV of the By-Laws provides that the By-Laws may be amended by a written document reflecting said amendment after having first been approved by a majority vote of the members of the Association.
- 3) After proper notice and vote by the members at a meeting duly called for the purpose of amending the By-laws it was voted by the required majority of members to amend the By-laws as reflected herein and said vote was recorded in the minutes of the Association.
- 4) The By-laws, Article V Section 1 currently reads:
  - " Section 1. Number. The affairs of this Association shall be managed by a Board of three (3) directors until the first annual meeting, and thereafter by (9) directors, who need not be members of the Association."

The By-Laws, Article VII Section 1 currently reads:

"Section 1. Nomination. Nomination for election to the Board of Directors shall be made a Nominating Committee. Nominations may also be made from the floor at the annual meeting. The Nominating Committee shall consist of a Chairman, who shall be a member of the Board of Directors and two or more members of the Association. The Nominating Committee shall be appointed by the Board of Directors prior to each annual meeting of the members, to serve from the close of such annual meeting until the close of the next annual meeting and such appointment shall be announced at each annual meeting. The Nominating Committee shall make as many nominations for election to the Board of Directors as it shall in its discretion determine, but

not less than the numbers of vacancies that are to be filled. Such nominations may be from among members or non-members."

## WHEREAS:

The homeowners, as members of the Victorian Village Townhouse Corporation have voted by at least a majority to amend Article V Section 1 and Article VII Section 1 of the By-Laws of Victorian Village Townhouse Corporation which vote was duly recorded in the minutes of Victorian Village Townhouse Corporation.

## NOW THEREFORE:

- 1) Article V Section 1 is amended to read as follows:
  - The affairs of this Association shall be managed by a Board of three
  - (3) Directors until the first annual meeting, and thereafter by nine
  - (9) directors, who must be members of the Association.
- 2) Article VII Section 1 is amended to read as follows:

Nomination for election to the Board of Directors shall be made by a Nominating Committee. Nominations may also be made from the floor at the annual meeting. The Nominating Committee shall consist of a chairman, who shall be a member of the Board of Directors and two or more members of the Association. The Nominating Committee shall be appointed by the Board of Directors prior to each annual meeting of the members, to serve from the close of such annual meeting until the close of the next annual meeting and such appointment shall be announced at each annual meeting. The Nominating Committee shall make as many nominations for election to the Board of Directors as it shall in its discretion Determine, but not less that the number of vacancies that are to be filled. Such nominations may be made from among members of the Association.

## NO OTHER MODIFICATION

Except as herein expressly modified and amended, each of the terms, provisions and conditions of the By-Laws and any prior amendments thereto shall remain in full force and effect, it being the sole intent of this amendment to amend the By-Laws as herein provided.
